#### **UNITED NATIONS SUSTAINABLE DEVELOPMENT GROUP (UNSDG) MEMBERSHIP**

1. The World Intellectual Property Organization (WIPO) has been invited to become a member of the United Nations Sustainable Development Group (UNSDG) (letter of invitation attached in the Annex).
2. The General Assembly in resolution 71/243, on the quadrennial comprehensive policy review of operational activities for development of the United Nations system (QCPR), called for a system-wide strategic document for collective action to support the implementation of the 2030 Agenda for Sustainable Development. In response to that call, the United Nations Secretary General (UNSG) presented a report entitled “Repositioning the United Nations development system to deliver on the 2030 Agenda: ensuring a better future for all” (A/72/124-E/2018/3). Seven measures were proposed by the UNSG for the repositioning of the UN system, including a system-wide strategic document to ensure collective responsibility and accelerate the alignment of the United Nations development system in support of the 2030 Agenda. The system-wide strategic document included among other actions, the revitalization of the United Nations Development Group (UNDG) to enhance strategic direction, impartial oversight and accountability regarding the system’s in-country contributions to the implementation of the agenda. The UNDG was renamed UNSDG and is comprised of a large number of UN agencies and programs (list attached in the Annex).
3. The WIPO Director General, after consideration of the invitation to become a member of the UNSDG, requested information on the proposed share in the cost allocation estimated for WIPO that would be intended to support the Resident Coordinator (RC) system for field work versus the proposed share that would be intended to support the implementation of the SDGs on a global basis. In this context, the WIPO Director General stated that given the predominately digital and virtual expression of many of WIPO’s programs and services, which is

also reflected in the presence of well over 95 per cent of WIPO staff at Headquarters in Geneva, the Organization's use of the resident coordinator system is significantly reduced as compared to that of other agencies.

5. The financial implication of becoming a UNSDG member is estimated at 400,000 Swiss francs per biennium. The formula for the membership cost sharing is currently being reviewed in the framework of the discussion on the QCPR and will be adopted at the forthcoming UN General Assembly.

7. Besides the financial implications, there may be administrative and reporting implications of becoming a member of UNSDG.

Dear Mr. Gurry,

I am writing to you in my capacity as Chair of the United Nations Development Group (UNDG) to invite the World Intellectual Property Organization to become a member of the renewed UNDG.

A recalibrated and impactful UNDG – more inclusive in its composition – is a critical stepping stone in the efforts of the Secretary-General to reposition the United Nations development system (UNDS). The 2030 Agenda for Sustainable Development is indeed a paradigm shift in the way we deliver support to countries and the people we serve – individually and across the system. Responding effectively will require significant changes in the skill sets, leadership and accountability mechanisms of the UNDS, with the UNDG at its center.

Moving forward, the UNDG will need increased capacities to steer and provide greater strategic direction, oversight and accountability to the UNDS. This is particularly true at the country level, where we envision the emergence of a new generation of United Nations country teams – guided by an enhanced and responsive United Nations development assistance framework and led by empowered and impartial Resident Coordinators.

In the coming weeks, the recalibrated UNDG will be renamed into the “United Nations Sustainable Development Group” (UNSDG). It will include all entities of the United Nations system that contribute significantly to the implementation of the Sustainable Development Goals at the country level. The observer status is to be eliminated. The list of proposed UNDG members has been updated accordingly, as outlined in the enclosed document.

In this regard, I would be delighted if you could join us for our forthcoming Principals meeting on Wednesday, 2 May 2018 at the International Organization for Migration Headquarters in London. The meeting will serve to discuss system-wide priority actions in support of the reform agenda of the Secretary-General to reposition the UNDS for the 2030 Agenda.
